THE DECLARATION OF ASSETS ACT 2018

**Regulations made by the Prime Minister under section 13 of
the Declaration of Assets Act 2018**

1. These regulations may be cited as the Declaration of Assets (State-owned Enterprises) Regulations 2019.
2. In these regulations –
“Act” means the Declaration of Assets Act 2018.
3. The Act shall apply to every State-owned enterprise specified in the Schedule.
4. These regulations shall come into operation on 24 August 2019.

Made by the Prime Minister on 22 August 2019.
