

## Guidelines for VIDEO COMPETITION on TikTok

- 1. The Financial Crimes Commission (FCC) is inviting youth aged between 18 and 35 from the Republic of Mauritius to participate in a competition by creating 30 to 60 seconds video(s) on TikTok to raise awareness about financial crimes, enhance youth engagement in the fight and promote a culture of accountability, transparency, and integrity.
- 2. The theme of the competition is: 'Pa les krim finansier detrir nou pei'.
- **3.** This competition is open to individual and group participation.
- **4.** All characters featuring in the video(s) should be aged between 18 and 35 years and their particulars should be submitted along with the video(s).
- 5. Participant(s) may submit more than one video.
- 6. **Registration** should be made through the following link: <a href="https://forms.gle/VzXT1RRniJgPw2mU7">https://forms.gle/VzXT1RRniJgPw2mU7</a> by **Wednesday, 28 May 2025.**
- 7. The deadline for submission of video(s) is Friday, 20 June 2025.
- 8. No registration will be accepted after Wednesday, 28 May 2025.
- **9. Attire:** Participants are expected to dress appropriately for the video(s).
- 10. The video(s) should address but not limited to the following aspects of financial crimes:
  - Create awareness of different types of financial crimes such as corruption, money laundering, financing of drug dealing and fraud offences;
  - Prevention of financial crimes;
  - Impact of financial crimes; and
  - Reporting of financial crimes.
- 11. Make sure the message is clear, informative, and related to fighting financial crimes in Mauritius.
- **12. Language:** Participants can create their video(s) in either **English, French or Mauritian Creole**. Just ensure that the message is easy to understand for everyone. Do not use offensive or harmful content and language. Keep the video(s) respectful and appropriate for all audiences.

- **13.** Avoid spreading misinformation, stick to verified facts and avoid anything that could mislead viewers.
- **14.** The video(s) should be original. Don't copy or reuse content.
- **15.** Do not include personal, sensitive, or private information in the video(s) that could compromise anyone's privacy.

## 16. Video submission:

Participants are requested to submit their video(s) as follows:

- (i.) Send the **TikTok link** along with the **MP4 video file** to the following email address: dramsohok@fcc.mu and cc: mramful@fcc.mu
- (ii.) Mention the FCC official TikTok account (@fccmauritius) when submitting the video(s) <a href="https://www.tiktok.com/@fcc mauritius">https://www.tiktok.com/@fcc mauritius</a>
- (iii.) Post the video (s) on TikTok using the following hashtags:
  - #fcc mauritius
  - #financialcrimescommission
  - #fightagainstfinancialcrimes
- (iv.) Ensure the TikTok video(s) is public for the judges/FCC to have access to;
- (v.) If required, caption the video(s) with a brief explanation of the idea or the key message behind it.

## 17. Winners will be awarded the following prizes:

| 1st Prize     | Rs 20,000 |

| 1st Runner Up | Rs 15,000 |
| 2nd Runner Up | Rs 10,000 |

- **18.** Decision of the jury will be binding and final.
- 19. Certificates of participation will be awarded to participants having satisfied the minimum criteria.
- **20.** All videos submitted will be the property of the FCC. By participating in the competition, each participant consents to his/her name and work, be used in whole or in part, by the FCC.
- **21.** The FCC reserves the right to disqualify any entry that does not comply with the stated terms or that is deemed inappropriate, offensive, or fraudulent.

- **22.** The FCC shall not be held liable for any loss, damage, or injury resulting from participation in the competition.
- 23. The FCC reserve the right to cancel, suspend, or modify the competition at any time without prior notice, due to unforeseen circumstances or events beyond their control. This includes, but is not limited to, technical issues, fraud, or any situation that compromises the integrity or fairness of the competition. In such cases, the organizers will not be liable for any loss or inconvenience caused.
