

SECTION IV

TERMS AND CONDITIONS

1. The Pleasure Craft will be sold on an **'where is' and 'As is' basis**.
2. The Pleasure Craft will be available for inspection at the Financial Crimes Commission (FCC) Headquarters, Réduit Triangle, Moka, on working days **from Monday 09 June 2025 to Friday 13 June 2025, between 10.00 to 15.00 hours**.
3. Bids containing proposals in sealed envelopes clearly marked **"Sale of a Pleasure Craft"** and addressed to the Acting Director, Corporate Services Division, should be deposited in the Tender Box located at the Reception Desk on Ground Floor, FCC Headquarters, Réduit Triangle, Moka, on or before **Friday 20 June 2025 by 14.00 hours at the latest**. Bids submitted after the specified deadline shall not be considered.
4. Bids shall be valid for a period of ninety (90) days after the closing date of the bids.
5. The offer will be awarded to the highest bid received without restriction. The best and highest bidder will be the Buyer, subject to the acceptance of the Commission.
6. Bids must be accompanied by a **banker's cheque drawn in favour of the FINANCIAL CRIMES COMMISSION for the sum representing 5% of the offer which will be realised and enforced immediately upon acceptance of the offer by the Commission**. The amount thereof will be **forfeited if the purchase is not finalised within fifteen (15) working days of acceptance**. Cheque accompanying Bids which are not accepted will be returned to the unsuccessful bidders.
7. Upon acceptance of the offer, **100% of the amount** inclusive of all taxes, where applicable, shall be payable to the Financial Crimes Commission (FCC) within **fifteen (15) days** of the date of acceptance of the offer, failing which the bid will be declared null and void.

8. The successful bidder should take delivery of the Pleasure Craft within fifteen (15) days from the date of issue of a Letter of Award, failing which the offer will lapse.
9. The successful bidder will be responsible for all costs including the removal and transportation of the Pleasure Craft in accordance with the laws and regulations from the Financial Crimes Commission (FCC) Headquarters, Réduit Triangle, Moka
10. The deed of sale and any other relevant documents will be drawn up in the name of the bidder(s), or as otherwise agreed by the bidder(s). All additional costs such as registration fee and duty payable, if applicable, shall be borne by the successful bidder.
11. On purchase of the Pleasure Craft, the successful bidder will have to transfer the Pleasure Craft to his/company name within fifteen (15) days and will have to submit the proof thereof to the FCC.
12. The FCC shall reject the proposal for the award if it determines that the bidder recommended for the award has directly or indirectly engaged in corrupt, fraudulent, collusive or obstructive practices for the bid in question.
13. The FCC has the discretion to ask for additional information / clarification from the bidder(s).
14. Any Bid received by email / fax shall be rejected.
15. The FCC reserves the right to accept or reject any offer and to cancel the bid exercise at any time prior to the award exercise without thereby incurring any liability to the affected bidder(s)
