**CONDITIONS OF THE SALE BY PUBLIC AUCTION TO BE HELD ON THE PREMISES OF
THE FINANCIAL CRIMES COMMISSION ON 27, 28, 29 AND 30 APRIL 2026.**

Bidders are requested to take cognizance of the following terms and conditions which will govern the Public Auction to be held at the Financial Crimes Commission (the “FCC” or the “Commission”) so that they cannot plead or pretend ignorance of same.

1. General conditions applicable to the Public Auction

- i. The Commission reserves the right to amend the list of motor vehicles and marine vessels listed in the Declaration, at any time prior to the Public Auction.
- ii. Viewing and inspection of all vehicles shall take place as follows:
 - (a) marine vessels, motorcycles, motorcars, trucks and construction machinery, on **Sunday 26 April 2026** as from **09:00 hours to 13.00 hours**; and
 - (b) the pleasure craft bearing registration number PPC 5756 OL 08 on **Friday 24th April 2026** from **10:00 to 12:00 p.m** at the Astrolabe Building, Caudan Waterfront Port Louis (behind Bank One).

- iii. Previous owners of the vehicles, their relatives, employees of the Financial Crimes Commission, and any person acting on behalf of, or having any direct or indirect interest in, the vehicles shall not be eligible to participate in the auction. The Sworn Auctioneer reserves the right to refuse to sell to any such person and to award the bid to the next highest bidder.
- iv. All successful bidders shall be subject to eligibility verification and due diligence checks prior to the conclusion of the sale. The Sworn Auctioneer and/or the FCC further reserves the right to reject, cancel, or revoke any sale where a participant fails to comply with the applicable eligibility criteria as set out above.
- v. The adjudication of the sale of the vehicle will be subject to the condition that the highest bid equals to or exceeds the minimum value as has been determined by a valuer, failing which the Sworn Auctioneer reserves the right not to proceed with the sale.

2. **Conditions applicable to the sale of vehicles on 27 and 28 April 2026**

- i. A deposit of Rs 25,000 shall be paid in respect of each vehicle immediately upon the adjudication. The deposit shall be non-refundable in case the successful bidder refuses to proceed with the sale. The deposit can be made in cash provided that it does not exceed MUR 500,000.
- ii. The remaining payment shall be made by way of bank cheque only.
- iii. Successful bidders are required to produce their original national identity card together with a photocopy thereof.
- iv. **Delivery of the vehicles shall take place, after full payment of the purchase price has been settled by the successful bidder, on the 27 and 28 April 2026 as from 13.30 hours 17.00 hours and on 29 April 2026 during business hours.**
- v. Successful bidders will be required to complete all formalities and requirements in relation to the registration of the vehicles in their own name at the level of National Land Transport Authority.

3. **Conditions applicable to the sale of marine vessels, motorcycles, trucks, construction machinery and any unsold vehicles on 30 April 2026**

- i. A deposit of Rs 25,000 shall be paid in respect of each vehicle immediately upon adjudication. The deposit shall be non-refundable in case the successful bidder refuses to proceed with the sale. The deposit can be made in cash provided that it does not exceed MUR 500,000.
- ii. Payment shall be made by way of bank cheque only.
- iii. Successful bidders are required to produce their original national identity card together with a photocopy thereof.
- iv. **Delivery of marine vessels, motorcycles, trucks, construction machinery and any unsold vehicles shall take place on the same day, i.e, 30 April 2026 during business hours.**

- v. Successful bidders will be required to complete all formalities and requirements in relation to the registration of the motor vehicles or marine vessels sold in their own name at the level of National Land Transport Authority or the Tourism Authority, as the case may be.
